Please remember we cannot guarantee to offer your child a place at any of the schools you have named as your new preferences on this form. However if we cannot offer your child a place at any of your preferred schools your child's name will be placed on the waiting list for each of the named schools and will remain there until the end of December 2021.

You child will only be removed from any waiting list before the end of December 2021 if:

- a) You change your preferences again and do not name the school.**
- b) We offer you a place at the school you named as your first preference.**
- c) We offer you a place at a school that has been ranked as higher preference.**
- e) You apply in writing to have your child removed from a waiting list.**

You still have a right of appeal for any school where your child has been refused a place, if you have not already appealed and if you lodge the appeal within 14 days of the refusal.
