

# Notice of Election

## Election of a Greater London Assembly Member for the City and East Constituency

---

- (1) If the election is contested, the poll will take place on **Thursday 6<sup>th</sup> May 2021**.
- (2) Nomination Forms for this election may be obtained from the Constituency Returning Officer, Election Services, Town Hall, Barking Road, London E6 2RP
- (3) Nomination papers must be delivered to the Constituency Returning Officer, Election Services, Town Hall, Barking Road, London E6 2RP between the hours of 10am and 4pm on or after the date of this notice (excluding weekends and bank holidays), but not later than **4pm on Tuesday 30<sup>th</sup> March 2021**.
- (4) Nomination papers must be accompanied by a deposit of £1,000, which may be made either in legal tender or in the form of a banker's draft (made payable to LBN – Elections Returning Officers A/C).
- (5) Applications to register to vote must reach the relevant Electoral Registration Officer \*\* by **midnight on the 19<sup>th</sup> April 2021**. Applications can be made online at [www.gov.uk/registertovote](http://www.gov.uk/registertovote).
- (6) Applications to vote by post or to change existing postal or proxy arrangements must reach the Electoral Registration Officer \*\* by **5pm Tuesday 20<sup>th</sup> April 2021**.
- (7) New applications to vote by proxy must reach the relevant Electoral Registration Officer \*\* by **5pm Tuesday 27<sup>th</sup> April 2021**.
- (8) Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the relevant Electoral Registration Officer \*\* by **5pm on Thursday 6<sup>th</sup> May 2021**.
  - a) The physical incapacity must have occurred after 5pm on **Tuesday 27 April 2021**.
  - b) To apply on the grounds of work/service the person must have become aware that they cannot go to the polling station in person after **5pm on Tuesday 27<sup>th</sup> April 2021**.
