# Infrastructure Funding Statement (IFS)

## Introduction

- 1.1 This IFS is for the financial year 2022/23 and sets out the income, allocation and expenditure relating to the Community Infrastructure Levy (CIL); and deeds of planning obligation (S106 Deeds), together with an overview of non-financial planning obligations.
- 1.2 The Council is required to produce and publish an IFS on an annual basis<sup>1</sup>. This statement must be published on the Council's website by 31 December 2023.
- 1.3 The format of this statement follows the requirements of the Community Infrastructure Levy Regulations 2010 (as amended) (the 'CIL Regulations'), the language used replicates the legislation to ensure that reports from different local authorities can be compared to each other.
- 1.4 Within the report there is an overview of:
  - what developer contributions are;
  - the 'CIL report';
  - the 'Section 106 report';
  - the 'infrastructure list' is included in this statement and also published separately on the Council's website at [www.newham.gov.uk/CIL](http://www.newham.gov.uk/CIL);
  - additional information related to Neighbourhood CIL projects and supplementary information related to S106 Deeds in the appendices.
- 1.5 The developer contributions back office monitoring system has been relied upon to produce this report supplemented with information from the Council's financial records; where there is a discrepancy the finance records take precedence.

## What are developer contributions?

- 1.6 Developer contributions is the umbrella term used to describe ways for the Council to receive money or other benefits; and control new development in the borough.
- 1.7 Developer contributions make sure that developments in the borough contribute towards investment in new or enhancing existing infrastructure across the borough and may facilitate service delivery; including the use of CIL and neighbourhood CIL monies.

- 1.8 Developer contributions negotiated by the Council through S106 Deeds ensure development contributes towards delivering or funding additional affordable housing; contributes towards the Council's skills and employment programmes (delivered by Our Newham Work) and tend to focus on controls and benefits in the area where development is happening.

### What is the CIL?

- 1.9 The CIL is charged on new development in the borough. CIL is a tariff based system and there are rules on the way the amount payable is calculated and whether a developer/land owner may be able to apply for a relief or exemption for paying (part or all) of the levy that is due.
- 1.10 The CIL monies collected are spent in accordance with the Council's Infrastructure List, which is reviewed annually. The Council has established that 20% of monies collected each year will subsequently be spent in consultation with local residents – this is known as the 'neighbourhood CIL'.
- 1.11 In addition to collecting funds for infrastructure in the borough, the Council also uses the same process to collect monies on behalf of the Mayor of London to fund the build costs of Crossrail (now known as the Elizabeth Line). ### What is a Deed of planning obligation?

- 1.13 Planning permission can be granted with conditions, which the Council use to control development. There are times when further controls are needed to minimise the impact on our communities or the people living or working within a new development, we will then use legal agreements between developers and the Council (and sometimes other parties) to assist in mitigating the impact of development to make it acceptable in planning terms, these are known as 'obligations'.
- 1.14 The obligations within a S106 Deed must meet three legal tests and be:
- necessary to make the development acceptable in planning terms;
  - directly related to the development; and
  - fairly and reasonably related in scale and kind to the development.

### Infrastructure List 2023/24

#### Introduction

CIL is money we collect from developments to invest in infrastructure to help support the development of the borough.

Newham Council is required annually to publish a list on our website of the types of projects we may fund with the CIL we collect from development across the borough. Councillors at a meeting of Newham Council's Cabinet agreed this Infrastructure List.

#### Purpose of the Infrastructure List

We want to be open about our plans for what we may fund via the CIL. This is to ensure that our residents, businesses and those who want to invest in the borough know what Newham Council intends to fund from the CIL. If a project or type of infrastructure is not listed below we currently do not have plans to make an investment of CIL funds in it but this may change in the future.

Your councillors have identified that there is a need for investment across all of the borough – not just where the new homes are being built or where jobs are being created.

#### What are the Council's priorities for investment?

The law says that the Strategic CIL cannot be spent on housing or affordable housing. Also, the Council cannot use the Strategic CIL to fund employability or economic support programmes like Our Newham Work. These remain corporate priorities linked to the growth and development of the borough but we cannot spend CIL on them.

The Building a Fairer Newham Corporate Plan and the Local Plan set Newham Council's strategic vision for how the borough will grow and develop. Alongside this Newham Council's Capital Strategy will set out the priorities for investment in Council infrastructure and the medium term financial strategy and annual budget will consider service delivery.

For 2023/4 the themes of projects or operations of the Council which will or may wholly or partly be funded via CIL are listed in the table below –

Provision, improvement, operation and maintenance of:
Town centres, local centres and employment uses; civic uses and community facilities
Public Realm – including walking and cycling initiatives which connect social and green infrastructure to our residents
Newham's parks, open spaces, green spaces
Play equipment; outdoor gym equipment in Newham's parks and housing areas
Newham's sports facilities
Newham's Education Facilities
Newham's Health & Social Care Facilities
Newham's Cultural Facilities

In March 2020, Cabinet agreed a framework of £1.6m of accrued neighbourhood CIL to be spent by the Community Assemblies programme (now known as People Powered Places).

Each community assembly (across the eight community neighbourhoods) was given a budget of £100k for 2021/22 (cycle 1) and £100k for 2022/23 (cycle 2).

The community assembly went through a participatory budget setting exercise during cycle 1 and 2 and a range of projects were selected by a resident vote to receive funding.

During 2022/23 some projects from cycle 1 were still being delivered; and cycle 2 projects started to be delivered.

Projects were delivered by residents; or the voluntary, community and faith sector (VCFS); or by the Council's Environment & Sustainable Transport team on behalf of residents.

This funding allocation is as follows:

- Cycle 1 - 2021/22:  
£100,000.00 to each of the 8no. community neighbourhoods for resident or VCFS-led schemes.  
£84,210.80: of enabling funding.<sup>10</sup>
- Cycle 2 - 2022/23:  
£100,000.00 to each of the 8no. community neighbourhoods for resident or VCFS-led schemes.

The following table sets out progress on the projects based on the monitoring undertaken by the Resident Engagement Team.
