## **Commissioning intentions:**

- The current contract has over six months remaining, and is due for re-procurement. It is likely that this contract will be extended by a further 6 months to allow for a planned procurement exercise to take place (see below).
- The Supporting Vulnerable Adults (SVA) Dynamic Purchasing Vehicle (DPV) will be utilised in order to re-procure this service. The SVA DPV is a vehicle facilitating more agile procurement of several service types (or Categories) via calloffs and mini competitions.
- Commissioners are currently working to develop Category 5: Shared Lives of the DPV.
- In Summer 2024, providers will be invited to apply for admittance onto the DPV. Following the conclusion of this exercise, commissioners will re-procure this contract via mini competition.
- Commissioners intend for a new Shared Lives contract with a revised service specification to be in place by June 2025.

#### Long term Arrangements

- In financial year 2023/24, Shared Lives supported a total of 58 different long term customers across the year, and ended the year with 60 ongoing long term arrangements.
- 2 long term customers moved on this year.

#### Day support

- In financial year 2023/24, Shared Lives provided day support sessions to 10 people who also live with Shared Lives Carers on a full-time basis. These are provided by different shared lives carers to enable the long-term carers to have a break.
- A total of 1086 day support sessions.

#### Respite

• In financial year 2023/24, Shared Lives provided 200 total of nights of respite to 8 people who live with their families, or who needed temporary support, e.g. after leaving hospital.
