Paying your personal assistants/carers:

From April 2024, the National Living Wage and the National Minimum Wage have increased. In Newham, it is compulsory to pay your PAs the London Living Wage (LLW) which is £13.15 (2014 rate).

When calculating your direct payment, we make sure to include the latest LLW rate in the costings so you can pay your PAs appropriately.

Training for PAs

Do you have a Personal Assistant who is interested in completing social care training? Know family members who would benefit from additional courses to support them in looking after loved ones?

We recommend all new PAs or carers complete the 'Care Certificate' course, covering essential modules like communication skills, health and safety, and safeguarding.

Right to work checks for those employing their own PA:

By law, you must check your PA's right to work in the UK. You will need to keep a copy of the documents they provide. Officers in our DP team will check this during their annual monitoring reviews You can check their status here: www.gov.uk/legal-right-work-uk

A Disclosure Barring Service (DBS) checks the applicant's criminal record. Your PA needs to have a DBS check. If they do not, they should apply for one. The cost of this check is incorporated into your direct payment. You can ask for a DBS as a condition of employment. You can check their record here: www.gov.uk/dbs-check-applicant-criminal-record

PAs can sign up for the DBS update service for automatic annual renewal. Visit the DBS Update Service here: www.gov.uk/dbs-update-service

Employers Liability Insurance (ELI)

If you have decided to employ a personal assistant, you will need to ensure you have an employer's liability insurance cover. The cost of this will be paid to you as part of your direct payment if you qualify for financial support from the Council towards the cost of your care.

Why do I need to have Employers Liability Insurance?

If your employee is injured whilst working for you and you are held legally liable, you will be protected to cover legal costs and compensation. As an employer, you are legally required to have Employers Liability Insurance in place. Please make sure you have the appropriate cover to protect yourself and your PA in case anything goes wrong. Our Direct Payments team will be able to help you through the process of purchasing insurance if you need their support.
